1. All applicants must submit a photo of their merchandise along with a Release of Liability Form and the \$50.00 entry fee. All applications should be sent as early as possible as space is limited and allocated on a first come first serve basis. **Your returned check is confirmation of your space.**
2. Make checks payable to: **Country Walk Master Association**. Please do not send cash. The cancelled check is your receipt. Mail check and application along with a photo to:

3. No space can be reserved without a signed application, Release of Liability form and the paid entry fee.
4. An accepted application is a commitment to show and no refund will be made for cancellation.
5. We reserve the right to place any artist in a space of our choosing.
6. No substitution of Artists will be allowed. Only the Applicant can occupy the space applied for.

Location & Set Up:

1. The festival will be held around the lake in the Country Walk HOA community located at 14601 Country Walk Drive, Miami, Florida. Set up begins at 6:00a.m. All booths must be set up and vehicles removed from the area no later than 8:30 a.m.
2. An information booth will be set up at 5:30a.m. the day of the festival. All artists must check in to receive their map and space number.
3. The \$50.00 fee grants the exhibitor a display area of 12x12. All artists are required to provide their own tables, tents, chairs, etc. and to set up in an attractive manner. We recommend that you come prepared with weather proof tarps to cover your merchandise in case of inclement weather.

Regulations:

1. All exhibited works must be presented in suitable form for public display. The Country Walk Master Homeowners Association reserves the right to accept products or companies that we feel will add variety and interest as well as compliment our other vendors in order to maintain a quality event. The Country Walk Master Homeowners Association reserves the right to refuse works that are unsuitable in Country Walk Master Homeowners Association's sole discretion.
2. Your space location card must be displayed on the windshield of your vehicle and should remain on your vehicle throughout the day.
3. A commitment to participate in the festival is a commitment to remain until the festival ends at 3:00p.m. Under no circumstances will vehicles be allowed in the artists' area before 3:00p.m. rain or shine.
4. Your signature on the Application and Release of Liability Form is your commitment to abide by the regulations of the Country Walk Fall Arts and Crafts Festival.
